## 3M Specific Terms and Conditions

"3M Software" means 3M's proprietary software listed on the applicable agreement between Allscripts and Customer, together with all 3M and Third-Party Content incorporated therein. "Third Party Content" means all non-3M owned software, algorithms, rules, analytical tools, materials and content incorporated into and distributed by 3M for use or in combination with the 3M Software.

"3M Output" means the output produced by the 3M Software as a result of running Customer's data through the 3M Software, including but not limited to, the creation and/or assignment of specific codes, edits, indicators, modifiers, flags or any other data or information.

1. The license to use and access of the 3M Software, including without limitation the Current Procedural Terminology (CPT®) materials including, but not limited to, nomenclature, codes and other content, and/or material published in CPT® Assistant (collectively referred to herein as "AMA Editorial Content") of the American Medical Association ("AMA") and the Health Forum LLC ("HF") content or UB-04 materials (referred to herein as "HF Editorial Content"), is non-exclusive and non-assignable, is limited to use in the United States and its territories, excluding Puerto Rico and the U.S. Virgin Islands ("Territory"). The 3M Software is solely for Customer's internal use and may only be used with Sunrise Financial Manager ("SFM") or Star Medical Records Abstracting ("SMRA") for the Authorized Use Cases. "Authorized Use Cases" means:

## For SFM:

SFM interfaces selected claim data to Grouper Plus Content Services ("GPCS") for MS-DRG, APR-DRG, APC, or EAPG grouping and pricing of expected reimbursement. For some payers, the DRG may be reported on the claim. The Grouper code and expected reimbursement amount along with selected other output data from GPCS is presented to an end-user within SFM user interfaces. Expected payment is compared with actual payment to generate payment variance work queues, and revenue cycle-related reporting associated with SFM, excluding any analytics reporting. Selected output data from GPCS that is stored in discreet database fields in SFM is available for work queue configuration and revenue cycle-related reporting associated with SFM, excluding any analytics reporting. The 3M Output may be delivered to, and stored within, SFM for access and use by, and transmission to, Customers and to support Customer's use of same. Customers may transmit the Claims Data (as defined below) to its payers. As used herein, "Claims Data" means only those elements of 3M Output required to be included in an EDI 837 transaction set and/or CMS-1500 or UB-04 form (or successors thereto) that is transmitted or intended to be transmitted by Customers to a third-party payer, as well as the expected reimbursement amounts associated with such claims.

## For SMRA:

SMRA interfaces to 3M Grouper Plus System ("GPS")and GPCS for an MS-DRG grouping, editing and reimbursement content when completing the abstracting process. The 3M Output may be delivered to, and stored within, SMRA for access and use by, and transmission to, Customers and to support Customers use of same. Customers may transmit the Claims Data to its payers.

- 2. Customer must hold the 3M Software confidential and may not allow a third party to access the 3M Software. Customer must not (i) use the 3M Software to process data for the benefit of any entity other than an authorized site expressly authorized in the applicable agreement between Allscripts and Customer (each an "Authorized Site") (ii) make the 3M Software accessible to any entity other than a reported Authorized Site, (iii) make any modifications, derivatives works of, disassemble or otherwise reverse engineer the 3M Software, or (iv) make copies of the 3M Software, except for archival and backup purposes.
- 3. The use of the 3M Documents, including without limitation AMA Editorial Content and HF Editorial Content, is non-exclusive and non-assignable. The 3M Documents are solely for Customer's internal use. Customer must hold the 3M Documents in confidence and may not allow a third-party access to the 3M Documents. Customer must not (i) provide, or make accessible, the 3M Documents to any third party, (ii) make any modifications to or derivatives of the 3M Documents, including the removal of any copyright or other proprietary rights notices, and (iii) make copies of the 3M Documents, except for archival and backup purposes. - 4. 3M AND ITS SUPPLIERS AND LICENSORS, INCLUDING WITHOUT LIMITATION THE AMA AND HF, PROVIDE THE 3M SOFTWARE AND 3M DOCUMENTS, INCLUDING ALL THIRD-PARTY MATERIALS INCLUDED THEREIN, "AS-IS" WITH ALL FAULTS. 3M AND ITS SUPPLIERS AND LICENSORS MAKE NO REPRESENTATION OR WARRANTY WHATSOEVER WITH RESPECT TO THE 3M SOFTWARE OR 3M DOCUMENTS, INCLUDING ALL THIRD-PARTY MATERIALS INCLUDED THEREIN, INCLUDING ANY (A) WARRANTY OF MERCHANTABILITY; (B) WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE; (C) WARRANTY OF TITLE; OR (D) WARRANTY AGAINST INFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS OF A THIRD PARTY; WHETHER EXPRESS OR IMPLIED BY LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE OF TRADE OR OTHERWISE.
- 5. TO THE MAXIMUM EXTENT PERMITTED BY LAW, 3M AND ITS LICENSORS OR SUPPLIERS, INCLUDING WITHOUT LIMITATION THE AMA AND HF, SHALL HAVE NO LIABILITY WHATSOEVER TO CUSTOMER OR ANY THIRD PARTY IN CONNECTION WITH CUSTOMER'S USE OF THE 3M SOFTWARE AND 3M DOCUMENTS. IN NO EVENT SHALL 3M OR ITS SUPPLIERS OR LICENSORS BE LIABLE TO CUSTOMER OR ANY THIRD PARTY FOR DIRECT, CONSEQUENTIAL, INDIRECT, INCIDENTAL,

SPECIAL, EXEMPLARY, PUNITIVE OR ENHANCED DAMAGES, OR LOST PROFITS OR REVENUES, OR DIMINUTION IN VALUE, ARISING OUT OF, RELATING TO, OR IN CONNECTION WITH CUSTOMER'S USE OF THE 3M SOFTWARE OR 3M DOCUMENTS, REGARDLESS OF (A) WHETHER SUCH DAMAGES WERE FORESEEABLE, (B) WHETHER OR NOT IT WAS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND (C) THE LEGAL OR EQUITABLE THEORY (CONTRACT, TORT OR OTHERWISE) UPON WHICH THE CLAIM IS BASED. THESE LIMITATIONS OF LIABILITY SHALL APPLY EVEN IF CUSTOMER'S REMEDIES UNDER THIS AGREEMENT FAIL OF THEIR ESSENTIAL PURPOSE.

  - c. Any printing or downloading of CPT Assistant from the 3M Software must be solely for Customer's internal business use, without any modification to the content, and in such a way that all references to the AMA are included.
  - d. The following U.S. Government Rights notice shall apply: This product includes CPT and/or CPT Assistant which is commercial technical data which was developed exclusively at private expense by the American Medical Association, 330 North Wabash Avenue, Chicago, Illinois, 60611. This Agreement does not grant a direct license to CPT or CPT Assistant to the Federal Government based on FAR 52.227-14 (Data Rights General) and DFARS 252.227-7015 (Technical Data Commercial Items) or any other license provision.
  - e. THE AMA DOES NOT DIRECTLY OR INDIRECTLY PRACTICE MEDICINE OR DISPENSE MEDICAL SERVICES. FEE SCHEDULES, RELATIVE VALUE UNITS, CONVERSION FACTORS AND/OR RELATED COMPONENTS ARE NOT ASSIGNED BY THE AMA, ARE NOT PART OF AMA EDITORIAL CONTENT, AND THE AMA IS NOT RECOMMENDING THEIR USE. THE AMA'S LICENSED CONTENT DOES NOT REPLACE THE AMA'S CURRENT PROCEDURAL TERMINOLOGY BOOK OR OTHER APPROPRIATE CODING AUTHORITY.
  - f. Customer may make backup copies of the 3M Software and 3M Output containing AMA Editorial Content for backup or archival purposes only, provided that all notices of

- g. The AMA is a third-party beneficiary of those terms and conditions of the Customer agreement, including these terms and conditions necessary to protect the rights and interests of the AMA with respect to AMA Editorial Content.
- h. Customer expressly consents to the disclosure of its name to the AMA by Allscripts or 3M for purposes of complying with 3M's agreement with the AMA.
- 8. The following terms and conditions apply to Customer's use of 3M Software and 3M Output containing HF Editorial Content:
  - a. Customer must maintain a separate license agreement with HF for the HF Editorial Content in the 3M Software and 3M Output. Upon request, Customer shall provide Allscripts verification of its license with HF.
  - b. FEE SCHEDULES, RELATIVE VALUE UNITS, CONVERSION FACTORS AND/OR RELATED COMPONENTS ARE NOT ASSIGNED BY HF, ARE NOT PART OF HF EDITORIAL CONTENT, AND HF IS NOT RECOMMENDING THEIR USE.
  - c. Customer may make backup copies of the 3M Software and 3M Output containing HF Editorial Content for backup or archival purposes only provided that all notices of proprietary rights, including trademark and copyright notices, appear on all backup or archival copies made.
  - d. HF is a third-party beneficiary of those terms and conditions of the Customer agreement, including these terms and conditions, necessary to protect the rights and interests of HF with respect to HF Editorial Content.
  - e. Customer expressly consents to the disclosure of its name to HF by Allscripts or 3M for purposes of complying with 3M's agreement with HF.
